**Q.** Why is Bilbao hosting the final when they are not involved in the tournament?

**A.** Any city can propose to be the venue for the final. Bilbao situated in Basque area with lots of rugby teams in the surrounding areas

**Q.** When trying to purchase a single ticket on Ticketmaster it is difficult to find as purchasers are not allowed to leave single tickets.

Advance sale for season ticket holders are not always good seats, but better seats are available in the general sale

**A.** Certain seats are held for sponsors, away teams etc and fast turnaround between matches affects this as well. This not intentional on the part of Leinster Rugby. Completing will be taken on board and looked at by LR

There will be a law change in relation to ticket charges e.g. per transaction v per ticket

**Q.** Why do Castore not do larger sizes. 3xl is largest

**A.** Taken on board

**Q.** If it is raining in Aviva, can supporters move to a different area to be under cover?

**A.** This is not possible as staffing resources have been applied in relation to tickets sold and therefore a safety issue

**Q.** Will new Anglesea Stand be fully covered?

**A.** Not fully but will be better than it was.
